*By signing this form, you are consenting to put your greatest treasure into our care, which is our honor and pleasure. We will do everything we can to keep your child safe as we participate in FULC Youth Ministry activities. Above and beyond that, each program we offer is intended to inspire growth of the individual and group in terms of faith and a sense of community. For each activity, we keep in mind safety considerations and emergency procedures so that if anything unfortunate happens we will be ready. However, unforeseen circumstances beyond our control do sometimes occur, and the statements below are intended to protect the congregation and staff of FULC in those situations.*

**LIABILITY RELEASE:** In consideration of accepting my child (aforementioned participant) for participation in any FULC youth ministry activity held on or off the church property during the period of August 1, 2017 – July 31, 2018, I hereby, for myself, my heirs, executors, and administrators, waive and release any and all rights and claims for damages that I may have against the above-named organization and its agents, employees, representatives, successors and assigns for any and all injuries suffered by my child that arise out of any such activity sponsored by the above-named organization. I warrant that I have the right to authorize the foregoing and do hereby agree to hold the above-named organization harmless of and from any and all liability of whatever nature which may arise out of or result from such participation. For the consideration stated above, I further agree that in the event my child make any claim against the above-named organization for damages arising out of any such activity sponsored by the above-named organization, I will personally indemnify, defend, and hold harmless the organization and its agents, employees, representatives, successors, and assigns against any and all loss and damage, occasioned thereby, including attorney's fees.

**MEDICAL TREATMENT PERMISSION:** I give permission to treat my child in case of a medical emergency, which may include, but not limited to, any x-ray, anesthetic, medical, surgical or dental diagnosis or treatment and hospital care, to be rendered to my child on the advice of any physician or dentist licensed under the provisions of the Medical Practice Act on the medical staff of a licensed hospital or emergency care facility. I shall be liable and agree to pay all costs and expenses incurred in connection with such medical and dental services rendered to my child pursuant to this authorization.

**TRANSPORTATION PERMISSION:** I give permission for my child to ride in any vehicle driven by an approved and licensed adult chaperone while attending and participating in activities sponsored by FULC. My child and I understand that seat belts must be worn at all times during transportation.

**EARLY RETURN HOME POLICY:** Should it be necessary for my child to return home due to medical reasons, disciplinary action or otherwise, I assume all transportation costs and responsibility.

**MEDIA RELEASE:** By signing below, I give permission for FULC to use photographs, videos, and other recordings, likenesses and images of my child in promoting activities sponsored by the church.

**CHAPERONES:** I give permission for my child to participate in FULC activities knowing that all chaperones are adult members of FULC in good standing and may or may not have undergone background checks; and also knowing that they will follow the guidelines in our Safe-Child policy to the best of their ability.

## Covenant of Expectations

The following rules and guidelines pertain to youth as well as adult leaders/chaperones.

### Non-Negotiable Rules

Any participant failing to abide by these rules will be sent home immediately at personal/family expense.

- No use or possession of drugs, alcohol, tobacco products or weapons of any kind.
- Participation with others in group activities is expected, including adherence to time-related instructions.
- No sexual misconduct (defined as exposure, touching, or inappropriate reference to body areas normally covered by undergarments).
- Sleeping areas for males and females will be separate. Co-ed visitation is only permitted when/where specified.

### Guidelines for Living in Christian Community

- Remember to always put God first in all situations, asking yourself "What would Jesus do?"
- Adults and youth will be equally responsible for performing assigned tasks in a timely and cooperative manner.
- Participants will be respectful and will maintain a positive attitude toward others at all times, recognizing Christ's presence in each other.
- Participants will be respectful of both common living spaces and the property of others.
- Participants will avoid the use of foul language or any speech (including "humor") which puts down, makes fun of, or stereotypes other persons or groups. No bullying behaviors in any form.
